The Energy Efficiency Council delivers a training and professional development program that supports the Council's mission to build a sophisticated market for energy management products and services that delivers:

The Council's training and professional development program:

- **Meets the current and future skills needs** of energy management service providers;
- **Enhances the capabilities of individuals** with energy management responsibilities; and
- **Contributes to the growth of the energy management sector.**

Certifications we offer

The Council offers two certification programs for energy management service providers:

1. The **Certified Measurement & Verification Professional (CMVP)**; and
2. The **Energy Efficiency Certification Scheme (EECS)**.

These certification programs upskill energy management professionals, thereby raising the standard of energy management services delivery. CMVP and EECS also help build confidence in the energy management market by allowing businesses and energy users to identify professionals that they can trust.

CMVP

The Council is the only Australian provider of the Efficiency Valuation Organization's Certified Measurement & Verification Professional training and exams, delivered in partnership with the US Association of Energy Engineers (AEE).

The right to use the CMVP title is granted to those who demonstrate proficiency in the M&V field by passing a 4-hour written exam and meeting the required academic and practical qualifications. EVO's certification level training is offered as preparation for the exam, and as a review of basic principles for experts.

With the initials CMVP beside your name, you are distinguishing yourself among those involved professionally in areas requiring the application of accurate and reliable measurement and verification methodologies. You will have demonstrated high levels of experience, competence, and specialised knowledge within your field.

EECS

The **Energy Efficiency Certification Scheme (EECS)** gives **business and government confidence** that an energy management professional will realise the best energy efficiency outcome for their buildings.

EECS certifies energy management professionals that have the skills and experience to lead and manage all types and scale of building energy upgrades, up to and including an integrated building energy retrofit (IBER) and to work effectively with their clients.

EECS offers two levels of certification for energy efficiency services providers. The two levels of certification – Certified Energy Efficiency Specialist (CEES) and Certified Energy Efficiency Leader (CEEL) – recognise industry professionals with different levels of knowledge and experience in the implementation of IBERs.

Training and professional development we deliver

For energy management service providers

The Energy Efficiency Council **supports professional development** by upskilling professionals on energy management fundamentals, and raising their understanding of crucial emerging topics. In the pursuit of meeting current and future skills needs, the Council holds various training and professional development courses, including:

- **Capturing the Value of Demand Response;**
- **Energy Auditing to the Australian Standard;** and
- **Energy Measurement and Metering.**

The Council also works with members and partners to design professional development programs that build the quality of energy management products and services by **enhancing energy management professionals' policy and technical expertise.**

All three of these courses provide continuing professional development (CPD) points for CMVP, EECS and other certifications recognised in Australia.

For businesses and energy users

The Council **drives business growth** by enhancing the capabilities of individuals with energy management responsibilities in Australian businesses. These courses are specifically designed for professionals without a background in energy management, but for whom have the responsibility of maintaining energy consuming assets and managing energy costs. To assist these professionals the Council delivers two introductory programs:

- **Energy management for business;** and
- **Building the business case for energy efficiency.**

The Council also works with partners to design professional development programs that support business decision making and growth by **enhancing businesses and energy users' energy literacy, energy strategy and energy management expertise.**
